

ORDINANCE NO: 2055

An Ordinance Amending On-Street Parking Regulations at St. Robert School

At a regular meeting of the Village Board of the Village of Shorewood, Milwaukee County, Wisconsin, held on the 21st day of September 2015, a quorum being present and a majority of the Board voting therefore, said Board does ordain as follows:

SECTION 1

That Section 500-19(G) Two-hour parking between 9:30 a.m. and 2:30 p.m. Monday through Friday of Section 500-19 Two-hour parking limit of Article VIII Parking Limits and Regulations of Chapter 500 Vehicles and Traffic of the General Ordinances of the Village of Shorewood shall be repealed:

E. Capitol Drive [Added 5-18-2009 by Ord. No. 1953]	North	From a point approximately 80 feet east of N. Maryland Avenue to N. Farwell Avenue from 9:30 a.m. to 2:30 p.m. Monday through Friday, on regular school days

SECTION 2

That Section 500-19(F) From 8:00 a.m. to 7:00 p.m., except Sunday and holidays, and where prohibited at all times or restricted to 15 minutes, or when restricted to permit parking only of Section 500-19 Two-hour parking limit of Article VIII Parking Limits and Regulations of Chapter 500 Vehicles and Traffic of the General Ordinances of the Village of Shorewood be amended to read:

E. Capitol Drive [Amended 2-6-2006 by Ord. No. 1907; 6-4-2007 by Ord. No. 1929; 7-14-2008 by Ord. No. 1941; 1-22-2013 by Ord. No. 2016]	North	From N. Maryland Avenue east to N. Prospect Avenue

SECTION 3

That Section 500-21(A) Ten-minute parking limit of Section 500-21 Ten- and fifteen-minute parking limits of Article VIII Parking Limits and Regulations of Chapter 500 Vehicles and Traffic of the General Ordinances of the Village of Shorewood shall be repealed:

<u>Name of Street</u>	<u>Side</u>	<u>Location</u>
E. Capitol Drive [Amended 7-12-2004 by Ord. No. 1872; 5-18-2009 by Ord. No. 1953]	North	From a point approximately 80 feet east of N. Maryland Avenue to N. Farwell Avenue, from 7:30 a.m. to 9:30 a.m. and 2:30 p.m. to 4:00 p.m. Monday through Friday, on regular school days.

SECTION 4

That Section 500-17(D) of Section 500-17 Parking Prohibited of Article VIII Parking Limits and Regulations of Chapter 500 Vehicles and Traffic of the General Ordinances of the Village of Shorewood shall be repealed:

<u>Name of Street</u>	<u>Side</u>	<u>Location</u>
N. Farwell Ave	West	From a point approximately 135 feet north of E. Capitol Drive for a distance of approximately 60 feet north thereof
N. Farwell Ave	West	From a point approximately 335 feet north of E. Capitol Drive for a distance of 92 feet north thereof between 7:30 a.m. and 8:00 a.m. school days


SECTION 5
