Next activities for Wilson Drive Task Force to get to end of job.

Goal: Each work group will develop at least one Wilson Drive Corridor plan focusing on the Concerns, Interests, and Ideas most important to the group. Try to keep the focus of your plan on the original purpose of your work group, i.e. Environment, Traffic and Safety, Parks and Recreation, and Development.

Steps 1 through 4 – July 27 Meeting Steps 5 through 8 – August 10 and August 24 Meetings Step 9 September 14 and 28 Meetings Step 10 October 12 Meeting

- 1. Each work group reviews the consolidated list of Concerns and Interests (C&I's).
 - a. Review each item and determine if it applies to the focus of your work group.
 - b. Do not include items directed at commercial or residential development on the west side of Wilson Drive.
 - c. We tried to group the C&I's by similarity.
 - d. If you feel there is an important C&I that was left off the list, please add it in one of the spaces.
- 2. Each group member will be given 10 dots to place next to the ten most important C&I's to her/him. Some C&I's are almost identical to others. Just pick one rather than multiples that convey the same meaning.
- 3. Tally the dots and rank the top 10 C&I's for your group. If dots are placed on very similar C&I's, combine them into one. For example, if 2 dots appear on #5 and 2 dots on #8, both related to bike access and safety, combine them into one.
- 4. The final list should reflect the 10 most important C&I's for your group.
- 5. Invite all work group members to attend the August 10 Steering Committee meeting.
- 6. Each work group reviews the consolidated list of Ideas.
- 7. Associate all relevant Ideas with your group's top 10 C&I's.
- 8. Develop one or more corridor alternatives using your Ideas.
 - a. Use a Keane map or aerial phots to plot your group's Ideas.
 - b. Determine the road width, structure and path that best suits your group's Ideas for each alternative.
 - c. Determine if you wish to invite guest speakers, use MySidewalk, or engage other tools to assist in evaluating the alternatives. Make specific recommendations for any of these.
- 9. Steering Committee will review all alternatives and determine how to proceed with presenting alternatives at the October public meeting. The review may include the use of quest speakers or other tools identified above. Set date for October public meeting.
- 10. Prepare for the public meeting.
- 11. Reflect on input from public meeting and decide what to present to the SIC.
