



Village of Shorewood Organics Collection Program Registration Form

The Village of Shorewood is recruiting households (in 1-, 2-, and 3-family dwellings) to participate in an exciting new organics collection program. The program features curbside cart collection for combined yard waste and kitchen scraps. Participants will be furnished 35-gallon rolling carts with locking lids at no charge. The monthly subscription fee will range on the amount of participation from Shorewood residents – rates illustrated on page 2. The amount will be automatically billed in quarterly installments by the collection vendor – Compost Crusader. Neighboring households are encouraged to share, but note that only one household will be billed. Enrollment will proceed on a first come, first-served basis, and 50 household increments will be accepted at a time.
