

ORDINANCE NO: 2085

An Ordinance Amending Parking Regulations Governing Parking Near Shorewood Schools on Days When School Is Not In Session

At a regular meeting of the Village Board of the Village of Shorewood, Milwaukee County, Wisconsin, held on the 2nd day of October, 2017, a quorum being present and a majority of the Board voting therefore, said Board does ordain as follows:

SECTION 1

That the portion addressing parking on "E. Lake Bluff Boulevard" included in Subsection 17, "Parking Prohibited," of Article VIII, "Parking Limits and Regulations," of Chapter 500, "Vehicles and Traffic," of the General Ordinances of the Village of Shorewood is hereby repealed and replaced to read as follows:

E. Lake Bluff Boulevard	North	From N. Bartlett Ave. east to Alley
E. Lake Bluff Boulevard	North	From N. Bartlett Ave. for a distance past Newhall Street of approximately 285 feet west thereof, between 7:30 a.m. and 4:30 p.m., Monday through Friday, except for passenger loading, on days in which the Shorewood School District is in session
E. Lake Bluff Boulevard	North	From N. Cramer Street to N. Oakland Avenue
E. Lake Bluff Boulevard	North	Between the Crosswalks at N. Newhall Street
E. Lake Bluff Boulevard	North	From N. Newhall Street for a distance of approximately 285 feet west thereof, between 7:30 a.m. and 4:30 p.m., Monday through Friday, except school buses, on days in which the Shorewood School District is in session
E. Lake Bluff Boulevard	South	From N. Morris Boulevard to N. Bartlett Avenue, 7:30 a.m. to 4:30 p.m., Monday through Friday, on days in which the Shorewood School District is in session

SECTION 2

That the portion addressing parking on “E. Lake Bluff Boulevard” in Subpart D, “From 7:30 a.m. to 4:30 p.m., Monday through Friday, except holidays,” contained in subsection 19, “Two-hour parking limit,” of Article VIII, “Parking Limits and Regulations,” of Chapter 500, “Vehicles and Traffic,” of the General Ordinances of the Village of Shorewood is hereby repealed and replaced to read as follows:


SECTION 3
